### Event Info

The Lionfish Removal and Awareness Day Festival I is a one-of-a-kind event, promoting lionfish removal and awareness. Alongside the festival will be the largest lionfish tournament in the world, the Emerald Coast Open.

The festival will be open to the public from 10 a.m. to 5 p.m. Saturday, May 14 & Sunday, May 15 in Destin. The headquarters of the festival and Emerald Coast Open tournament will be hosted at AJ's Seafood and Oyster Bar, with the festival continuing along the HarborWalk Village. The event typically brings in 5,000 - 7,000 visitors each year.

Note: HarborWalk village hosts permanent vendors year-round. Because of this, vendors for this event are not permitted to sell food, drink, or other concessions.

#### Set Up & Breakdown

Vendor set up is Saturday, May 14 from 7 a.m - 9:30 a.m. Breakdown is Sunday, May 15 at 5 p.m. Additional information regarding set-up protocol and vendor assignments will be provided at a later date.

#### **Parking**

Public parking lots are available just north of HarborWalk Village. Additional parking and traffic flow details will be provided at a later date. For more information, visit <u>FWCReefRangers.com</u>.

# <u>Security</u>

There will be overnight security at HarborWalk Village from 5 p.m. through 9 a.m. on May 14 and 15. We ask that you please breakdown your booth Sunday afternoon at 5 p.m. since security will not be provided on May 16. Although security is provided, the Florida Fish and Wildlife Conservation Commission is not responsible for lost or stolen items.

# <u>Equipment</u>

One 10'x10' tent will be provided to each vendor. Please bring your own tables, chairs, and any other items you may need. Keep in mind that the event is located along Destin harbor and could be affected by strong winds or inclement weather. *Be prepared and bring equipment to weigh down your tents and other materials*. Some tent spots will have access to electrical outlets. If your booth requires the use of an electrical outlet, please let us know on your application. We cannot guarantee power, but we will do our best to accommodate all vendors' requests for electrical outlet access.

# **Disruptive Activities**

Vendor shall not engage in any activity that is disruptive. Vendors that engage in disruptive activities will be subject to removal and/or forfeiture of their vendor registration fee.

#### **Release of Liability**

Vendor hereby agrees to release, waive, and discharge the Florida Fish and Wildlife Conservation Commission, Fish and Wildlife Foundation of Florida and their employees, sponsors, volunteers and agents from all losses, damages, claims, costs, expenses and liabilities, including attorney fees, for injury to person or property arising in connection with my participation in Lionfish Awareness and Removal Day and Emerald Coast Open activities and use of facilities and equipment.

#### Vendor Selection

Due to social distancing, there are a limited number of availabilities for vendors. If there are more applicants than booth spaces available FWC will make selections based on the following; vendor has been involved in LRAD in previous years, vendor directly relates to lionfish and or marine conservation, and date of application received. Vendors will not be able to choose spaces, FWC lionfish staff will assign them. Vendors will not be able to reserve multiple booth spaces due to limited availability; each vendor will be assigned 1 space. FWC will select vendors by April 1st, 2022.
